Bob Timmons presented several thoughts about the possibility of incorporating an auxiliary or junior board for the younger members of BSTF board of directors. After discussion, it was felt that there was no need in having such a board.

Each member was provided with Investment Analysis Summary of the Foundation as of July 15, 1991, prepared by the Mercantile Bank of Joplin N. A. (A copy is included with these minutes.) Duane also reviewed the most current financial statement of the Foundation, June 30, 1991, which showed the total assets to be \$3,351,775 which included \$168,165 of

accumulated income available for distribution at this meeting. The ending market value of the Foundation a year ago was \$2,973.722.29.

Friday evening, President George S. Timmons had asked each member of the Foundation to report on those requests that were formally presented for consideration. There were a total of 72 requests of which 30 were selected to receive grants which totaled \$121,400.
